
As you are aware, the number of cases of COVID-19 in the country is witnessing an alarming upward trend. The Hon'ble Prime Minister convened a high level meeting on 4th April, 2021 to review the emerging situation, following which it has been decided to focus on the five-fold strategy to deal with the emerging crisis viz. Testing, Tracing, Treatment, COVID appropriate behaviour and Vaccination.

2. It is therefore imperative that all stakeholders within the Central and State Governments take forward the communication strategy with renewed emphasis on 'Dawai Bhi, Kadai Bhi'. This would require your assistance, for instance, by displaying posters, embedded messaging and interpersonal communication through functionaries, etc. The Action Points of Ministry of I&B are at Annexure-I. and a list of suggested activities of various Central Government Ministries/Departments is at Annexure-II.

3. The campaign for COVID-19 Appropriate Behaviour will be a 'Low Cost People's Campaign (Jan Andolan)'. The approved creatives for the "Jan Andolan" will be shared tomorrow on 7th April, 2021, which should be disseminated to continue the awareness process. Respective Departmental Publicity Officers of the Ministry may be contacted for Creatives in regional languages. Dear Chief Executive,

It has been decided that an intensive and focussed campaign will be launched in the country to re-emphasize the importance and significance of following the COVID related social behavior norms including wearing masks, social distancing and hand washing/hygiene. In this regard, the following action plan has been finalized in respect of Central Public Sector Enterprises (CPSEs).

- (i) All CPSEs will display posters, banners and billboards on COVID related social behavior norms such as wearing masks, social distancing and hand washing/hygiene in their offices, units of production, townships and medical facilities. The details of townships and medical facilities of CPSEs available with DPE are enclosed at Annex 1 and Annex 2 respectively. In case any CPSE is not covered, the requisite details may be emailed to lokeshbajpai.ofb@nic.in for updation.
- (ii) All CPSEs will undertake an awareness campaign on COVID related social behavior norms through SMS and other social media tools to target their employees.
- (iii) The CPSEs undertaking CSR activities in 112 Aspirational Districts identified by NITI Aayog (list at Annex 3) will additionally undertake awareness campaign on COVID related social behavior norms through posters, banners and billboards in all Aspirational District Headquarters.
- (iv) Maharatna and Navratna CPSEs having significant social media presence will leverage their social media outreach to spread awareness campaign on COVID related social behavior norms.

2. In this regard, a copy of letter no. 57/Secy (I&B)/2020 dated 7th October, 2020 from Secretary, Ministry of Information & Broadcasting along with its enclosures (including creatives and COVID-19 pledge) is annexed (Annex 4) for the purpose of maintaining uniformity in the campaign awareness material.

3. All Chief Executives of CPSEs are requested to undertake the above tasks on a mission mode and furnish the details of implementation by their company and subsidiaries in the enclosed format (Annex 5) on weekly basis by every Friday beginning with 9.10.2020 through email to lokeshbajpai.ofb@nic.in and e-Samiksha portal of DPE.
